APPROVE FY 2001-02 CONTRACT WITH SHORELINE OCCUPATIONAL SERVICES FOR THE POST-EMPLOYMENT CAREER ADVANCEMENT PROJECT

Dear Members of the Board:

As you may recall, Shoreline Occupational Services was awarded a performance based contract in October 2000 to provide career advancement counseling services for participants in the Careerworks Division of the Hamen Resources Agency (HRA.) The purpose of this letter is to request your Board's approval for a new contract with Shoreline Occupational Services to continue providing project services for an additional year. Funding for this project is included in the FY 2001-02 budget.

Services provided by this project include employment counseling for newly employed Careerworks participants, career advancement planning, and assistance for both employers and employees to arrange job-related skill upgrade training. Over the past year, Shoreline Occupational Services has exceeded performance standards as set forth in their first year contract and has served over 100 Careerworks participants, helping them to retain jobs, advance in their careers, and progress toward self sufficiency and economic independence.

The total cost for this project is \$156,011 for Fiscal Year 2001-02; \$150,911 funded by the CalWORKs program and \$5,100 funded by the Workforce Investment Act. A complete copy of this contract is on file with the Clerk of the Board.
