RE: COMMUNITY SUPPORT FOR RELIEF EFFORTS IN RESPONSE TO THE TERRORIST ATTACKS ON AMERICAN SOIL ON SEPTEMBER **11, 2001**

Dear Members of the Board:

Drawing on incredible personal strength and national spirit, the people of the United States continue to absorb the shock of the tragic events which occurred on September 11, 2001, and also continue their heroic efforts towards recovery and restoration. I have been joined by others in hoping that Santa Cruz County government could demonstrate our support to those who have suffered from this cowardly act in a very tangible way, including coordination of some form of a financial contribution to relief and recovery efforts.

The people of the Santa Cruz County community have demonstrated their desire to provide meaningful assistance in light of this national affront. Models exist of how communities have responded in the past to disasters. During our own earthquake recovery, the people of the San Mateo County community demonstrated their desire to provide meaningful assistance to earthquake victims in Santa Cruz by raising private donations through an effort coordinated and authorized by the San Mateo County Board of Supervisors. County Counsel notes an independent effort or an effort in conjunction with the following long-established relief organizations would be an appropriate vehicle for a County response. I have been advised by County Counsel that a direct

cash donation would be in violation of the State Constitutional prohibition against making gifts of public funds.

A number of local avenues exist for area residents to demonstrate our unity during this time of national crisis, some **of** which include:

American Red Cross

A local blood drive will be held on Thursday, September 27, 2001, from 12:30 until 5:30 p.m. at the First Presbyterian Church on the corner of Highway 1 and Mission Street. It should be noted that this is the regular monthly blood drive sponsored by the Red Cross and only a limited number of appointments are available. Community members interested in donating blood should call 1-800-448-3543 to schedule an appointment.

In addition, the Santa Cruz County Chapter of the American Red Cross is accepting cash, check or credit card donations to its various disaster funds.

- Cash or check Cash contributions should be hand delivered and contributions by check can be hand delivered or sent to the Santa Cruz Chapter of the American Red Cross at their office at 2960 Soquel Avenue, Santa Cruz, CA 95062.

In order to ensure that donations are channeled to the proper fund, checks should be made payable to the "American Red Cross" and must specify donations as being earmarked for either the "National Disaster Fund," the "New York Disaster Fund," or the "Local Disaster Fund."

Large Blood Drive

The County Health Services Agency will be assisting the local Red Cross chapter in conducting a large blood drive which will take place on Wednesday, October 3, 2001, from 12:00 noon until 5:30 p.m. at the County Health Center at 1080 Emeline Avenue (located in Building D) in Santa Cruz. The drive will be held in the Auditoriums in the basement of Building D. County staff will assist the Red Cross by making appointments for potential blood donors. Beginning Monday, September 24, potential blood donors should call 454-5482 to schedule an appointment.

> It should be noted that the Red Cross is limited in its capacity to accept donors. However, blood donations are always needed and the County will ask the Red Cross to sponsor additional blood drives to meet the community requests to donate the gift of life.
