SUBJECT: 2000/2001 PAVEMENT MANAGEMENT SLURRY SEAL PROJECT

Members of the Board:

On September 6, 2001, the Santa Cruz County Sanitation District Board of Directors approved a road resurfacing plan that related to roads effected by the District's on-going sewer rehabilitation projects, primarily located in the Live Oak area. This plan calls for slurry sealing select roads depending on their pavement condition following the sewer work. The District's plan was developed in coordination with the Department of Public Works Pavement Management Plan. Under this coordinated effort, the Santa **Cruz** County Sanitation District will pay for all work on those roads affected by the sewer work, including seven private streets.

Graham Contractors, Inc., the prime contractor for the County's 2000/2001 Pavement Management Slurry Seal Project has agreed to complete this additional work at the already established contract unit price. Attached for your Board approval is Contract Change Order No. 3 in the amount of \$20,708.52. This change order will add to the contract slurry seals on Assembly Lane, Brommer Street, East Cliff Drive, Hampstead Way, Lakeview Drive, Melanie Place, Moran Lake Parking Lot, Park Place, Place Street, Prather Lane, and Tony Court. The Sanitation District will be funding this work.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve Contract Change Order No. 3 in the amount of \$20,708.52.

2. Authorize the Chairperson of the Board to sign the contract.
3. Direct the Clerk of the Board to return the signed documents to Public Works for further processing.
