NOTICE OF COMPLETION FOR 100 ROUNTREE RE-ROOF PROJECT

Members of the Board:

The subject project was completed on October 15, 2001. The Contractor was Bustichi Construction Inc. The original bid amount was \$189,940. This project consisted of re-roofingthe Sheriffs Rountree facility located at 100 Rountree Lane in Watsonville. There have been two change orders to this project which reduced the final cost of the project by \$1,796. These changes included modifying the sheet metal flashing and changing the roof underlayment from 30 lb. felt to 30 lb. modified bitumen base underlayment. The total construction cost is \$188,144.

Therefore it is RECOMMENDED that your Board take the following actions:

- 1) Accept the project as completed;
- 2) Approve the final cost of \$188,144; and
- 3) Authorize the Clerk of the Board to file the executed Notice of Completion with the Office of the County Recorder, a copy of which is attached.
