2001-2002 EMERGENCY WINTER SHELTER PROGRAM

Dear Members of the Board:

As you know, the Emergency Winter Shelter Program provides shelter to homeless individuals and families in our community during the cold and rainy months of the year through a collaboration between area churches, the Salvation Army, and the Homeless Services Center (HSC). The Homeless Services Center, formerly known as Citizens' Committee for the Homeless, administers the program at the National Guard armory in North County, while the Salvation Army provides shelter in South County. The purpose of this letter is to update you on the status of state funding and armory availability, to describe the proposed program for the 2001-2002 fiscal year, and to request authorization to execute agreements to implement the program.

Status of State Funding and Armory Availability

As you may recall, last year the State made several changes in the way that emergency winter shelter is funded. In contrast to prior years, when the State allocated funding directly to the National Guard for use of the armory, funds are now included in the Emergency Housing Assistance Program (EHAP) dollars allocated to counties using a formula based on poverty and unemployment rates. For FY 2001-2002, the State has made over \$13 million available to counties; funds may be used for year-round shelter, including emergency winter shelter. Applications for funds are due to the State on November 15,2001, and awards will be made in January 2002.

2001-2002 EMERGENCY WINTER SHELTER PROGRAM

This year, the National Guard has increased the armory rental fee from \$325 to \$352 per night, resulting in a total cost of \$53,504 for Santa Cruz County's program. As you are aware, the National Guard is being deployed in a number of areas throughout the United States for assistance with "homeland security." The National Guard has informed HRA that the Santa Cruz Armory is currently available for emergency winter shelter use; however, if the local National Guard becomes fully deployed, the armory could, on a few days' notice, become unavailable for shelter. HRA is working with the City of Santa Cruz to develop alternative options in the event that this situation arises.

Proposed Winter Shelter Program for 2001-2002

The Winter Shelter Program in Santa Cruz County is operated by HSC and the Salvation Army. The program continues to coordinate the efforts of local churches and will operate again this year in sites at local churches, the Watsonville Salvation Army, and the Santa Cruz Armory.

A total budget of \$161,407 for facilities and program costs has been prepared (Attachment 1). Budgeted costs reflect increased armory rental, utilities and transportation costs. The budget provides for 137 shelter nights from November 15,2001, through March 31, 2002, at the Salvation Army, and for 152 nights from November 15,2001, through April 15,2002, at the Santa Cruz Armory.

For administrative ease, local county homeless service providers again collectively agreed that North County's HSC will apply for the EHAP fbnds. Attachment 2 details the proposed financing for the Winter Shelter Program for FY 2001-2002 and compares this year's recommended funding contributions to those for the previous year. As in prior years, the County's funding commitment will be contingent on commitments from all of the local jurisdictions. The Cities of Santa Cruz, Scotts Valley, and Capitola have already provided funds to the Homeless Services Center for Winter Shelter Program costs; the Watsonville City Council will be considering the request at its November 13 meeting.

The proposed County share of the Emergency Winter Shelter Program cost is \$30,423. This contribution includes \$4,107 for the Homeless Services Center and \$26,316 for the Salvation Army shelter programs. As was done for FY 2000-2001, funds from the County's Housing Fund, administrated by the Redevelopment Agency, will be used to support this effort. In addition, the County is directly responsible for reimbursing the National Guard for use of the armory. As in FY 2000-2001, HSC will provide HRA with armory rental funds in the amount of \$53,504 from the FY 2001-2002 EHAP allocation. Thus, HRA requests your Board's approval to accept a total of \$83,927 in unanticipated revenue from the County's Housing Fund and HSC for the Emergency Winter Shelter Program.

2001-2002 EMERGENCY WINTER SHELTER PROGRAM

In order to operate the Emergency Winter Shelter Program for the 2001-2002 fiscal year, it is necessary to execute a license agreement with the National Guard for the use of the Santa Cruz Armory for winter shelter this year, as well as contracts with the ISSP and Salvation Army to operate the shelter facilities. In addition, HRA is preparing a Memorandum of Understanding with HSC specifying that HSC will provide the County with \$53,504 in allocated funds received from the State's Emergency Housing Assistance Program for armory rental costs. The license and contracts contain similar provisions as previous years' agreements and are in the process of final preparation. These agreements include:

- A license agreement with the National Guard for 152 nights of shelter in the Santa Cruz Armory, at a cost not to exceed \$53,504
- A contract with the HSC in an amount not to exceed \$4,107
- A contract with the Salvation Army in an amount not to exceed \$26,316

During the past year, new data have become available—including the 2000 Homeless Census and Needs Assessment and the 2000 U.S. Census—that make it possible to update the formula that has been used to determine the jurisdictions' fair share of cost for the Emergency Winter Shelter Program. Several of the jurisdictions have expressed interest in revisiting the formula in light of these data. HRA recommends working with the County Administrative Office to bring the jurisdictions together to assess appropriate cost sharing for next year's emergency winter shelter program.

IT IS THEREFORE RECOMMENDED that your Board:

- 1. Approve the attached resolution accepting unanticipated revenue in the amount of \$83,927 to Index 391200 for FY 2001-2002;
- 2. Authorize the Human Resources Agency Administrator to execute a license agreement with the National Guard for use of the Santa Cruz Armory in an amount not to exceed \$53,504;
- 3. Authorize the Human Resources Agency Administrator to execute a contract with the Homeless Services Center for the provision of winter shelter facilities for FY 2001-2002 in an amount not to exceed \$4,107;
- **4.** Authorize the Human Resources Agency Administrator to execute **a** contract with the Salvation Army for the provision of winter shelter facilities for FY 2001-2002 in an amount not to exceed \$26,316; and
- 5. Authorize the Human Resources Agency Administrator to take any other necessary actions related to the provision of emergency winter shelter **in** the 2001-2002 fiscal year.
