SUBJECT: East Cliff Drive Parkway and Bluff Stabilization Project

Dear Members of the Board:

The County Department of Public Works has been awarded a State Coastal Conservancy grant of \$75,000 for the construction of a bicycle and pedestrian pathway along East Cliff Drive. One of the requirements of the grant is that the County accept six Offers to Dedicate, or OTDs (see Exhibit 1). On May 23, 2000 your Board directed the Parks Department to report back on this date with regard to the status of the project and recommendations for acceptance of the six OTDs.

An application for the East Cliff Drive Parkway and Bluff Stabilization Project has been submitted to the Planning Department and consultants have been hired to prepare an environmental impact report (EIR). The Draft EIR is expected to be released for public review in early 2002, followed by the preparation of the Final EIR and public hearings before the approving bodies. Construction plans for Phase I (bluff stabilization) will then be prepared with construction of Phase I in 2003, followed by construction of Phase II (parkway improvements) in 2003/2004.

Typically, the County would purchase the OTDs just prior to construction in 2003, thus deferring the onset of maintenance costs to the County. However, one of the OTDs expires on March 9,2002. Your Board may wish to consider accepting that specific OTD, APN 028-142-35, sooner in order to ensure meeting grant requirements.

It is therefore RECOMMENDED that your Board take the following actions:

- 1. Adopt the attached resolution accepting the offer of dedication for APN 028-142-35.
- 2. Direct the Clerk of the Board of Supervisors to have the resolution recorded by the County Recorder.
- 3. Direct the Redevelopment Agency to report back to your Board in June 2002 with a status report on the East Cliff Drive Project, to include use of the Coastal Conservancy funds and coordinate with the Parks Department on preparing a recommendation of when the remaining five OTDs should be accepted.
