RE: VACANCIES ON THE SANTA CRUZ METROPOLITAN TRANSIT DISTRICT BOARD **OF** DIRECTORS

Dear Members of the Board:

Attached is a letter dated October 31, 2001, from Leslie R. White, General Manager of the Santa Cruz Metropolitan Transit District, advising that the term of office of two appointees to the Transit District Board of Directors, appointed by the Board of Supervisors, will expire on December 31, 2001.

As Board members are aware, while the terms of appointments to the Transit District Board are for a period of four years, our Board makes appointments of its membership on an annual basis to various agencies, committees and commissions, and we will next consider appointments in mid-January, 2002. Accordingly, I believe it would be appropriate to reappoint Supervisor Beautz to the Transit District Board of Directors until such time as our year 2002 appointments are made.

In order to provide an opportunity for interested residents to submit applications for the second position, I believe that we should formally post notification of this vacancy.

Accordingly, I recommend that the Board take the following actions:

2. Accept this letter as notification **of** an at-large vacancy on the Santa Cruz Metropolitan Transit District Board **of** Directors, with nominations for appointment to be received on December 4, 2001, and final appointment **to** be made December 11, 2001.
