APPROVAL OF WELFARE-TO-WOW TRANSPORTATION CONTRACT

Dear Members of the Board:

On June 19, 2001, your Board approved a contract extension with the Santa Cruz Area Transportation Management Association for the Emergency Ride Home Program for CalWORKs Welfare-to-Work participants through September 30, 2001. The purpose of this letter is to renew that contract for the period from October 1, 2001 through June 30, 2002.

The Emergency Ride Home Program was established with finding from a Job Access Reverse Commute grant, which ended September 30, 2001. It provides emergency transportation vouchers for CalWORKs participants who are working or engaging in welfare-to-work activities when their regular transportation fails. Funds to extend the contract through the end of the fiscal year were budgeted in the Human Resources Agency FY 2001-2002 CalWORKs budget. A contract has been negotiated in the amount of \$25,000, approved by County Counsel and Risk Management and signed by the contractor. The contract is on file with the Clerk of the Board, and will involve no additional cost to the County.

IT IS THEREFORE RECOMMENDED that your Board approve a continuing contract with the Santa Cruz Area Transportation Management Association in the amount of \$25,000 from October 1,2001 through June 30, 2002, and authorize the Human Resources Agency Administrator the sign the contract on behalf of the County.
