#### CIVIL SERVICERULE CHANGE

## Dear Members of the Board:

The Civil Service Rules establish the probation period for all positions covered by the Civil Service System. At the Commission's regular meeting on October 17, a change in probation period for a position was considered, and is recommended to your Board for concurrence.

This item concerns establishing a twelve-month probation period for the position of Deputy Agricultural Commissioner/Sealer, rather than the standard six month period. All of the licensed positions subordinate to this position maintain a one-year probationary period. Consistency within the department is achieved by extending that requirement to this classification. The work of the Agricultural Commissioner's Office is seasonal, requiring a full year for incumbents to be exposed to the full array of challenges facing the office. This position is represented by the Middle Management Association, which was notified of this proposal and is in concurrence.

The change in probation period requires approval of both the Civil Service Commission and the Board of Supervisors as it represents an amendment to the Civil Service Rules. The change in probation period for this position is contained in the attached resolution.

Therefore, IT **IS** RECOMMENDED that your Board adopt the attached amendment to Resolution No. **247-76** to amend the Personnel Regulations with the attached revisions to the Civil Service Commission rules, as attached.
