SHERIFF'S ACTIVITY LEAGUE GRANT FOR THE PURCHASE OF TWO TRAILERS

Dear Members of the Board:

On November 7, 2000, your Board approved the submittal of a grant application to the State Department of Parks and Recreation to fund the purchase of two fifteen passenger vans to be used to provide adequate transportation for at-risk youths to participate in planned trips and sports activities sponsored by the Sheriff's Activity League (**SAL**). The Sheriff's Department was awarded this grant in the amount of \$68,920 and on December 1, 2000, your Board approved the purchase of two vans. We purchased these two vans for a total amount of \$56,225 leaving an available balance of \$12,725.

These vans have been very successful and **SAL** has transported hundreds of kids to events. These events include Junior Giants Baseball, surfing/body boarding, camping trips, snow trips, a Safe Skateboard Program and many more. The only area we have difficulty with is the transportation of the equipment for these events.

The Sheriff's Office contacted the State Department of Parks and Recreation for the viability of using the balance of the funds to purchase two enclosed utility trailers to transport sport equipment needed for *SAL* events. As a result, we have been authorized to purchase two trailers for an amount not to exceed \$12,725.

It is therefore RECOMMENDED that your Board take the following actions:

1. APPROVE the attached Resolution Accepting Unanticipated Revenue (AUD60) from the State of California, Department of Parks in the amount of \$12,725;
2. AUTHORIZE the total amount of \$12,725 for the purchase of two enclosed utility trailers for the SAL program for an amount not to exceed \$12,725;


