APPROVAL OF REVENUE AGREEMENT FOR TRANSITIONAL HOUSING PROGRAM

Dear Members of the Board:

As you are aware, since October 1992, the Human Resources Agency, the Housing Authority and Families in Transition of Santa Cruz County have jointly operated a highly successful transitional housing program for homeless families with children. The program, currently in its tenth year, is partially funded by a multi-year grant from the Department of Housing and Urban Development (HUD). Under the HUD grant, case management services are provided by a social worker who is employed by HRA, stationed at Families in Transition, and partially funded through a subcontract agreement from the Housing Authority. The HUD grant has been renewed for another three-year period. The purpose of this letter is to recommend approval of a three-year revenue agreement for this program.

The Housing Authority and HRA have developed the attached agreement to provide HUD funds for case management services from October 1, 2001 through September 30, 2004. In addition, an attached amendment to the agreement will provide for rehabilitation of some of the housing units. The grant provides \$23,333 per federal fiscal year, or a total amount of \$70,000 over the three years. The new grant allocation began October 1, 2001 and the annual amount increased slightly, therefore, it will be necessary to adopt a resolution accepting \$3,691 as unanticipated revenue.

The attached revenue agreement and amendment involve no additional cost to the County, The agreement and amendment have been approved by County Counsel and Risk Management and signed by the Housing Authority.

IT IS THEREFORE RECOMMENDED that your Board:

1. Approve the revenue agreement and amendment between the Housing Authority of the County of Santa Cruz and the Human Resources Agency for a total of \$70,000 from October 1, 2001 through September 30, 2004;
