#### SUBJECT: DAVENPORT UNDERGROUND UTILITY DISTRICT 17 MODIFICATION OF BOUNDARY

Members of the Board:

On September 12,2000, your Board adopted a resolution amending the previously approved boundary of the Davenport Underground Utility District 17, adding Fair Avenue and Old Coast Road east of Fair Avenue to the original district.

Following that action, staff has worked with the utility companies to include these areas in the design. However, at the easterly end of Old Coast Road, several structures have been constructed around utility poles. The utility companies are not able to work on these poles in their current condition, and in order to allow the utility undergrounding project to proceed, it is proposed that the easterly 250 feet of Old Coast Road be removed from the district. The proposed amended boundary is shown on the attached map.

In order to amend the district boundary, it is necessary to hold a public hearing on the proposed revisions.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Adopt Resolution of Intention to amend the boundary of Underground Utility District 17, Davenport, as shown on the attached map.
- 2. Set a public hearing at 9:00 a.m. or thereafter on January 15,2002, pursuant to County Code Section 9.74.030 (B).

3. Upon conclusion of the public hearing, consider adoption of the Resolution Amending the Boundary of Underground Utility District 17, Davenport.

BE IT FURTHER RESOLVED AND ORDERED that the Clerk of the Board of Supervisors shall give notice to all affected property owners and utility companies by mail of the time and place of such hearing at least 15 days prior to the date set for said hearing and by publication of this resolution for ten days pursuant to Government Code Section 6062a at least ten days prior to said public hearing in the Santa Cruz Sentinel, a newspaper of general circulation.
