## **Application of Living Wage Ordinance to Redevelopment Agency**

Dear Members of the Board:

On December 4,2001 your Board, acting as the Board of Supervisors, adopted in-concept a Living Wage Ordinance which requires vendors providing particular types of services to the County to pay their employees a minimum living wage. In response to your Board's earlier concern that this Ordinance apply to the Agency's activities, staff indicated at that time that we would return with actions that would allow your Board to formally apply that Ordinance to Agency activities at the time of final adoption of the Ordinance. Final ordinance adoption is scheduled elsewhere on this agenda.

While the Ordinance provides explicitly that it will apply to all County entities, including the Redevelopment Agency, County Counsel advised that your Board also approve a resolution for the Agency's action to formalize that policy. The attached resolution has been prepared for that purpose.

It is therefore RECOMMENDED that your Board, as the Board of Directors for the Redevelopment Agency adopt the attached resolution formally subjecting the Redevelopment Agency to the requirements of the Living Wage Ordinance.
