
**RESOLUTION OF THE BOARD OF SUPERVISORS

RELATING TO CALIFORNIA OPEN SPACE  
SUBVENTION PROGRAM FUNDING**

WHEREAS, the California Code of Regulations (Section 14111(a)) requires each local agency participating in the Open Space Subvention Program to adopt a resolution designating an Authorized Representative for the Open Space Subvention Program; and

WHEREAS, as a local agency which operates an agricultural preserve and land conservation contract program under the Williamson Act (Government Code section 51200 et seq.), Santa Cruz County participates in the Open Space Subvention Program and desires by this resolution to clarify its designation of an Authorized Representative for the Open Space Subvention Program;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Santa Cruz that the individual whose name, title and specimen signature appears immediately below is hereby designated as the Authorized Representative and as such is authorized to execute for and on behalf of the County of Santa Cruz, a political subdivision of the State of California, all documents required of Santa Cruz County under the California Open Space Subvention Program.


