## SUBJECT: SET PUBLIC HEARING ON FEBRUARY 5,2002, TO CONSIDER AND TO ADOPT IN CONCEPT THE MORAN LAKE COUNTY PARK BUTTERFLY HABITAT MANAGEMENT PLAN

Dear Members of the Board:

At the 2000-2001 budget hearings (June 27, 2000), your Board approved the Department of Parks, Open Space & Cultural Services budget, which included funding in the amount of \$50,000 for the preparation of a Butterfly Habitat Management Plan (BHMP) at Moran Lake County Park.

Parks Department staff negotiated a contract with Joni L. Janecki & Associates, Inc. for the butterfly habitat management planning services in the amount of \$48,590, which fell within the anticipated budget for the project and on March 27, 2001, your Board approved the contract.

The public meeting process has been proceeding well. To date, two Parks Commission public meetings, one public on-site "field trip," and one Parks Commission public hearing have occurred.

At the Parks Commission public hearing on November 19, 2001, the Parks Commission approved the BHMP "in concept" and recommended that it be forwarded to your Board for a public hearing and conceptual adoption. Conceptual adoption of the proposed BHMP by your Board will allow the environmental review (CEQA) process to begin.
