Members of the Board:

The subject project was completed on December 10, 2001. The Contractor was California Commercial Roofing Systems Inc. This project consisted of the design and the re-roof of the County Health Clinic located at 9 Crestview Drive in Watsonville. The original bid amount was \$171,900. There has been one change order to this project, approved by the Director of General Services in the amount of \$1,650, as authorized by your Board. This change was for a new roof hatch. The total construction cost is now \$173,550.

Therefore it is RECOMMENDED that your Board take the following actions:

- 1) Accept the project as completed;
- 2) Approve the final cost of \$173,550; and
- 3) Authorize the Clerk of the Board to file the executed Notice of Completion with the Office of the County Recorder, a copy of which is attached.
