Increase Fixed Asset Appropriation For Index #423000 (ISD Duplicating Division)

Dear Members of the Board:

During the FY 2001-02 budget hearings, your board approved \$20,000 in fixed asset appropriations for the Information Services Department (ISD) Duplicating Division to purchase a mail processing machine. After reviewing the available models to replace the current machine, it has been determined that an increase of \$5,000 is needed.

The current mail machine is past its useful life and is in need of immediate replacement. To ensure uninterrupted mail processing service, the Information Services Department is seeking to replace this machine as soon as possible. A review of available vendors indicates that the current estimated cost of replacing the mail machine is approximately \$25,000 (or \$5,000 more than the original appropriation of \$20,000). The \$5,000 in additional funds that are required will be transferred from index #423000/ subobject#3360 (equipment maintenance).

It is therefore RECOMMENDED that your Board approve an increase to the fixed asset appropriation for index #423000 in the amount of \$5,000 and transfer \$5,000 from index #423000/3360 to purchase a mail processing machine.
