30th, 32nd, 33rd Avenues Drainage Project Financing

Dear Members of the Board:

As you will recall, in February of 2001 your Board as the Board of Supervisors, approved a construction contract with Reber Construction for construction of the 30th, 32nd, 33rd Avenues Drainage Project. In a separate letter on today's agenda, the Public Works Department is asking your Board, as the Board of Supervisors, to approve two change orders and to supplement the project extra work item. In order for the funds necessary to increase the construction contract to be available, a parallel action is required from you, as the Board of Directors of the Redevelopment Agency.

The contract for this project includes the construction of sewer and drainage improvements throughout the area, curbs, gutters and sidewalks on 30th Avenue, and re-paving of all the streets in the area. Because of a number of factors, particularly delays in receiving the final permit from the Coastal Commission, the project has suffered some delays. Nonetheless, the current schedule calls for completion of the project by late January, barring further weather delays. As explained in the Public Works Department letter, the contractor has discovered that the County's estimates for paving were low as they were based upon an overlay rather than grinding and re-paving, causing the need to increase the funding for the pavement portion of the project.

In addition to that additional funding, we will encounter additional costs in complying with a number of the Coastal Commission's permit requirements. Finally, we anticipate some additional costs related to poor soil conditions recently discovered on 30" Avenue. In total, we anticipate that these would require an additional Agency allocation of \$45,000 for the project, accomplished through a transfer from project reserves. A resolution authorizing the transfer of funds is included as Attachment 1.

Redevelopment Agency staff has determined that the project is of benefit to the Project Area, that no other reasonable means of financing the improvements are available to the community, that the project will assist in the elimination of blight, and that the project is consistent with the Redevelopment Agency's Five Year Implementation Plan.

It is therefore RECOMMENDED that your Board, as the Board of Directors for the Redevelopment Agency, take the following actions:

- 1. Approve the attached Resolution Accepting Unanticipated Revenue totaling \$45,000 from the Redevelopment Agency Capital Projects Bond Proceeds Reserves;
- 2. Approve an additional \$31,800.00 in Agency funds to supplement the project extra work item described in DPW's letter; and
- 3. Concur with and adopt the associated findings.
