Subject: Web-based Financial Reporting Application

Dear Members of the Board:

In fiscal year 1994-95 we began using the online financial management system FAMIS. Since that time we have updated the system to a new release version for the year 2000, have made revisions and modifications to accommodate new legal and reporting requirements, and have created additional reports to meet the needs of the departments. However, the reporting module of FAMIS does not have the flexibility to effectively produce the wide variety of specialized reports and access to data that our users require.

We have reviewed the situation with the County Administrative Office, Information Services and Public Works, and there is a consensus that a web-based solution will best meet the County's needs. Simpler Systems, Inc. proposes a hosted, web-based financial reporting application to allow users to access current and historical financial data exported from the County's mainframe financial system. The application will be hosted by Simpler Systems, who will be responsible for all server hardware, software and maintenance. We have looked at several systems and found that this system, which was designed specifically for financial applications, provides the nicest and easiest to use features.

The proposed system will:

• Permit easy online access of current and historical data to all FAMIS users, including remote locations, without special transmission links,

- Allow departments to download data into spreadsheet or database applications for specialized reporting,
- Provide departments with the ability to choose and print their financial reports as they need them, and
- Eliminate the huge volume of paper reports that are currently generated by FAMIS and manually distributed.

The cost of Simpler Systems' services include a one-time Setup and Configuration fee of \$15,000, and an ongoing Application Hosting fee of \$750 per month. As a result of savings in the purchase of the check printing system, we have sufficient savings in our budget to accommodate this acquisition.

IT IS THEREFORE RECOMMENDED that your Board:

- 1. Approve the transfer of \$18,000 from Software to Professional Services, and
- 2. Authorize the Purchasing Agent to execute the needed purchase order and contract with Simpler Systems, Inc.

County of Santa Cruz Proposal for Reporting Application

This proposal is for a hosted, web-based financial reporting application to allow County staff to access current and historical financial data exported from the County's mainframe financial system. The application will be hosted by Simpler Systems, who will be responsible for all server hardware, software and maintenance.

Reporting Features

- Simple chart of account criteria selection via drop-down lists;
- o Hyperlinks on displayed data elements allowing drill-down to other more detailed reports;
- Dynamic creation and download of printable reports in PDF format;
- Dynamic creation and download of displayed data to client workstation in Microsoft Excel (.xls) or comma-delimited (.csv) formats.

General Application Features

- Secure user ID / password-based authentication mechanism to identify users;
- Role based data filtering to limit user access to balances and transactions based on chart of account segments;
- Administration pages for maintaining users, roles, and notifications;
- User-maintainable preferences for chart of account criteria;
- Secure Sockets Layer (SSL) encryption for all client communication.

Data Transfer features

- Secure internet file transfer of chart of account, balance, and/or transaction data to Simpler Systems application server;
- Fully automated and scheduled data transfer process requiring no user interaction;
- Simple data file formats (fixed-length, delimited, or xml);
- Built-in data compression to minimize bandwidth usage.

System requirements

- Client: Microsoft Internet Explorer (version 4.0 or greater) or Netscape Navigator (version 4.08 or greater)
- Web and Database Server: None (hosted by Simpler Systems).

Pricing:

Pricing is comprised of two components:

- One-time Setup and Configuration fee: \$15,000.
- Ongoing Application Hosting fee: \$750 per month.
