Annual Report of the Santa Cruz County On-site Sewage Disposal Technical Advisory Committee 2001

<u>Purpose:</u> This committee was established by the Environmental Health Director to advise Environmental Health Services on the review and development of ordinances, policies, and procedures regarding the installation, maintenance and ongoing management of onsite sewage disposal systems in Santa Cruz County.

Major topics discussed by the Committee in 2001 included:

- Monitoring and Management of Alternative Systems
- Sale Inspections and Pumper Reports
- Update to Septic System Repair Standards
- MOU with Regional Water Quality Control Board
- Implementation of AE? 885 for improved management and use of septic systems statewide
- Standards for Second units served by Septic Systems
- Revised Site Evaluation Form
- Winter time erosion control during and after septic installations
- EHS staff at Remote Permit Centers
- Use of final sign-off sheet and inspection sheets
- Need for Improved Plot Plans for septic proposals

Work on monitoring and maintenance programs and implementation of AB 885 will continue in 2002, along with discussion of other items of concern that arise.
