

ORDINANCE AUTHORIZING AMENDMENT TO THE CONTRACT BETWEEN
THE COUNTY OF SANTA CRUZ AND THE BOARD OF ADMINISTRATION
OF THE CALIFORNIA PUBLIC EMPLOYEES' RETIREMENT SYSTEM

The Board of Supervisors of the County of Santa Cruz do ordain as follows:

SECTION I

That an amendment to the contract between the Board of Supervisors of the County of Santa Cruz and the Board of Administration, California Public Employees' Retirement System to provide Section 21023.5 (Public Service Credit for Peace Corps or AmeriCorps: VISTA Service) for Local Miscellaneous and Safety Members is hereby authorized, a copy of said amendment being attached hereto, marked as an Exhibit, and by such reference made a part hereof as though herein set out in full.

SECTION II

The Chairperson of the Board of Supervisors is hereby authorized, empowered and directed to execute said amendment for and on behalf of the County of Santa Cruz.

SECTION III

The second reading of this Ordinance shall take place on February 26, 2002, more than 20 days after the first reading.

SECTION IV

This Contract amendment shall take effect on the 32nd day following the adoption of the Ordinance.

SECTION V

This Ordinance shall take effect on the 31st day after the date of the final passage.
