On July **28,** 1999, the parcel map for MLD 97-0525 was recorded. The developer of the project completed construction of the required improvements on July **3**1, 2001. The Public Works Department inspected the constructed improvements and found that they are complete and acceptable.

In order for the County to assume maintenance responsibilities for Parcels "A" and "B," it will be necessary for your Board to formally accept Parcels "A" and Parcel "B" into the County maintained road system.
