# Financing for Redevelopment Office Remodel

Dear Members of the Board:

Elsewhere on this agenda your Board, as the Board of Supervisors, is being asked to approve a contract for remodeling the offices of the Agency staff. This is a project that has been in the planning stage for many years and will dramatically improve the office environment and recognize the significant changes that have taken place in the office structure and staff levels over the past decade.

Funds for the anticipated remodel project have been held in reserves awaiting the successful outcome of the bid process. In order to provide the funds needed to cover the contract and related office furniture reconfiguration it is necessary at this time to appropriate those funds within the current budget.

It is therefore RECOMMENDED that your Board, as the Board of Directors for the Redevelopment Agency, approve the two attached AUD 60As which will enable the transfer of funds to General Services for the remodel contract and the Agency's administrative budget for the internal modular furniture reconfiguration.
