RE: ACCEPTING AND APPROPRIATING UNANTICIPATED REVENUE FROM THE CALIFORNIA LAW ENFORCEMENT TECHNOLOGY EQUIPMENT PURCHASE (CLETEP III) PROGRAM

Dear Members of the Board:

In its Fiscal Year 2001/02 budget, the California Legislature appropriated \$35.4 million to be distributed to local law enforcement agencies for technology expenditures for front line officers. This funding has already been distributed to local law enforcement agencies on a per capita basis. The Santa Cruz Sheriffs Office received \$110,083 in California Law Enforcement Technology Equipment Purchase (CLETEPIII) Programfunding. This letter is intended to provide your Board with background information, request approval to provide additional funding towards the purchase of a message switcher (communication link between the Sheriffs Office and the Department of Justice) and the purchase of 17 laptop computers.

As your Board is aware, the Sheriffs Office, working closely with the County Administrative Office and the County Information Services Department, is undertaking a comprehensive reevaluation, reconfiguration and improvement of its technology and information management systems. The four major areas being addressed are: the Records Management System, the Detention Management System, the message switcher and installation of Mobile Data Computers in all of the patrol vehicles. The Sheriffs Office is also in the process of replacing older version laptop computers with new laptops for use by officers in the field. The new laptops will have the ability to work faster, provide more memory and have CD-ROM capability to improve efficiency.

This multi-year effort is proceeding with the acquisition of software and interface tools and the necessary hardware and related equipment. At this time, the Sheriffs Office is requesting that your Board authorize funding in the amount of \$59,083 towards the equipment component of this project by providing funding towards the purchase of a message switcher; and approve \$51,000 to be used to purchase 17 laptop computers.

It is therefore recommended that your Board:

- Adopt a resolution accepting and appropriating unanticipated revenue in the amount of \$ 110,083 of California Law Enforcement Technology Equipment Purchase (CLETEP) funds;
- 2. Approve set aside of \$59,083 towards the purchase of a message switcher; and
- 3. Authorize the purchase of 17 laptop computers for front line law enforcement officers in the amount of \$51,000.
