SUBJECT: DEMOLITION CONTRACT AMENDMENT

Members of the Board:

This contract provides for the demolition of the structure at 2970 Fern Flat Road under the Landslide Hazard Litigation Program. In order to comply with the requirements of the County's Geologist, additional site work was completed to provide adequate site stability measures. Because the additional work was not included in the original contractor's bid, a contract amendment is required in the amount of \$500. This will bring the total cost for demolition of this site to \$27,900.00 and the total contract, which includes work on another site, to \$37,875.00.
