RE: PAY ADJUSTMENT FOR SHERIFF'S OFFICE EMPLOYEE

Dear Members of the Board:

It has recently come to our attention that an employee of the Sheriff's Office did not receive the appropriate amount of career differential pay for two pay periods. This letter is intended to provide your Board with background information and request the Auditor-Controller process a pay adjustment.

In October 2001, the Sheriffs Office processed a Personnel Action Form for Deputy Shea Johnson to transfer her from the Patrol index (661300) to the Court Security index (664001). The career differential should have remained as an integral component of her pay. Due to an administrative error that occurred when the action form was processed, her career differential was turned off for pay period 23 and 24. The total amount owed to Shea Johnson is \$82.16.

The Sheriff's Office administrative and payroll staff are now aware of these oversights and will monitor future transfers for accuracy.

It is, therefore, RECOMMENDED that your Board request the Auditor-Controller to process a pay adjustment for Deputy Shea Johnson in the amount of \$82.40.
