On February 26,2002, the Board of Supervisors received 13 bids for the Spanish Ranch Road, PM 0.20, Storm Damage Repair project. All bids were found to be in order. The engineer's estimate was \$104,300. The low bidder was Coast Mountain Excavating of Los Gatos, California, in the amount of \$86,525. Sufficient funds are available in the 2001/2002 Road Budget to cover this expenditure including contingencies and administration.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Accept the low bid of Coast Mountain Excavating in the amount of \$86,525 and authorize award of the contract.
- **2.** Authorize the Director of Public Works to sign said contract on behalf of the County of Santa Cruz.
