#### Members of the Board:

For a number of years, a poor drainage pattern existed in the County right-of-way along Gross Road and at its intersection with Coffee Lane. When Tract 1431 was proposed, for a site downstream of this location, an opportunity presented itself to resolve that drainage problem in an expeditious and economic manner. At Public Works' request the developer agreed to include drainage improvements upstream of the project and connect these improvements to the proposed drainage system on the tract site. The storm drain line within the subdivision had to be larger in size to accommodate the additional flow from Gross Road and the upstream drainage area. Since Gross Road is upstream of the project, and therefore not subject to any drainage impacts from the subdivision, Zone 5 staff offered to recommend to your Board that fee credit be granted for the additional work done, in an amount not to exceed the drainage fees paid by the subdivision. The Planning Commission strongly supports the fee credit as stated in the attached subdivision permit Item No. III, D. 6.

The Zone **5** impact fees paid by the Rodeo Creek Subdivision were \$31,250. The developer is requesting reimbursement of these costs, as stated in the attached letter. The actual cost of the drainage improvement as constructed was \$42,120, as shown in the attached contractor cost breakdown. It is a customary practice for the Department of Public Works to offer reimbursement of the construction of drainage improvements (up to the amount of Zone 5 fees paid) when the improvements benefit the County, and the constructed improvements are not associated with the project's impact on existing drainage problems. The \$31,250 reimbursement can be funded by transferring \$14,987 from Zone **5** Expansion Construction Contingencies and \$16,263 from current year Zone 5 revenue.

It is therefore recommended that the Board of Directors take the following action:

- 1. Approve AUD-74 transferring \$14,987 from Santa Cruz County Flood Control and Water Conservation District, Zone 5, Expansion Construction Contingencies to DPW Services.
- 2. Approve reimbursement to The Holcomb Corporation in the amount of \$14,987 for the Rodeo Creek Subdivision offsite improvements.
- 3. Authorize the Auditor/Controller to refund \$16,263 from current year revenues to The Holcomb Corporation for the Rodeo Creek Subdivision offsite improvements.

Any changes that are on the final plans that in any way do not conform to the project conditions of approval shall be specifically illustrated on a separate sheet and highlighted in yellow on any set of plans submitted to the County for review.

- III. Prior to recordation of the Final Map, the following requirements shall be met:
  - A. Pay a Negative Declaration filing fee of \$25.00 to the Clerk of the Board of the County of Sanra Cruz as required by the California Department of Fish and Game mitigation fees program.
  - B. Submit a letter of certification from the Tax Collector's Office that there are no outstanding tax liabilities affecting the subject parcels.
  - C. Meet ail requirements of the Santa Cruz County Sanitation District as stated in the District's letter dated June 28, 1998, including, without limitation, the following standard conditions:
    - 1. Submit and secure approval of an engineered sewer improvement plan providing sanitary sewer service to each parcel,
    - 2. Pay all necessary bonding, deposits, and connection fees.
  - D. Submit and secure approval of engineered improvement plans from the Department of Public Works for all roads, curbs and gutters, storm drains, erosion control, and other improvements required by the Subdivision Ordinance, noted on the attached tentative map and/or specified in these conditions of approval. A subdivision agreement backed by financial securities (equal to 150% of engineer's estimate of the cost of improvements), per Sections 14.01.510 and 511 of the Subdivision Ordinance, shall be executed to guarantee completion of this work. Improvement plans shall meet the following requirements:
    - 1. All improvements shail meet the requirements of the County of Santa Cruz Department of Public Works Design Criteria Manual except as modified in these conditions of approval. The improvement plans shall include a pedestrian and bicycle path to connect the Catalina Drive cul-de-sac with "Via Gargano", and to connect "Via Gargano" to Coffee Lane Park to the north. The path shall be an easement no less than eight feet in width, arid no less than four feet in paved width.

- In-order to improve access for emergency vehicles and to comply with General Plan-policy 6.5.5, the developer shall provide a crash gate and appropriate pavement striping to replace the barrier in the cul-de-sac of Gross Road. (\*\*\*PC 2-23-00\*\*\*)
- 3. A detailed erosion and sediment control plan for the subdivision shall be integrated with the improvement plans and shall be submitted to the Planning Department, Environmental Planning Section, for review and approval prior to submittal to the Department of Pubiic Works and approval of the Final Map. The plan shall include a clearing and grading schedule, clearly marked disturbance envelope, revegetation specifications, temporary road surfacing and construction entry stabilization, details of temporary drainage control including lined swales, erosion, protection at the outlets of pipes, sediment barriers around drain inlets, etc.
- 4. A landscape plan for areas designated on the tentative map shail be submitted for Planning Department review and approval prior to submittal to the Department of Public Works. Wherever irrigation for landscaping is required, stub outs for water service shall be shown on the improvement plans. The landscape plan shall be compared to the utility plan to prevent placement conflicts. No change in the landscape plan shall be granted without County review.
- A full soils engineering investigation shall be prepared and shall be reviewed and accepted by the County Planning Department. A plan review letter from the geotechnical engineer shail be submitted with the plans, stating that the plans have been reviewed and found to be in compliance with the recommendations of the geotechnical report.
- Engineered drainage plans shall be reviewed and approved by the Zone 5 drainage district. Appropriate fees for new impervious surface shall be paid.

  \*\*\*Drainage fee credits are recommended to the Board of Directors for Zone 5 and are strongly supported by the Planning Commission for the off-site improvements at Gross Road and Coffee Lane up to the amount of the Zone 5 drainage fees assessed.

- 7. All new utilities shall be constructed underground. All facility relocations, upgrades or installations required for utilities service to the project shall be noted on the improvement plans. All preliminary engineering for such utility improvements is the responsibility of the developer.

SUBJECT: STORM WATER NATIONAL POLLUTANT DISCHARGE ELIMINATION

SYSTEM PHASE II PERMIT

Members of the Board:

On January 15,2002, your Board directed the Department of Public Works to report back to you on the status of the National Pollutant Discharge Elimination System (NPDES) program regulations and implementation of the federal storm water discharge program.

Under the authority of the Clean Water Act, the Environmental Protection Agency (EPA) established the NPDES storm water program in 1987. Phase I of the NPDES program was implemented in 1990 to regulate storm water discharges from large municipalities, industrial and construction operations. The EPA extended the storm water program to cover small municipal storm sewer systems (MS4s) and smaller industrial and construction operations under Phase 11 in 1999. The intent of the EPA's Phase 11 rule is to improve water quality by reducing urban runoff.

The County of Santa Cruz is required to comply with NPDES Phase 11 regulations. Regulated small MS4s were determined based on population and defined urbanized areas as designated by the U.S. Census Bureau. Under the Phase II rule, the County must submit an NPDES permit application to the State Water Resources Control Board (SWRCB), our NPDES permitting authority by March 2003. A storm water management program (SWMP) must be developed and submitted as part of the NPDES permit application.

The County's SWMP must satisfy the Clean Water Act requirements and should improve water quality by limiting urban runoff and reducing pollutant loadings into our ground and surface waters to the "maximum extent practicable." The EPA requires that Phase II SWMPs specify best management practices (BMP) for the following six specific minimum control measures.

- Public Involvement/Participation Program
- Public Education and Outreach Program
- Illicit Connection/Discharge Program
- Municipal Operations Control Program
- Construction Site Discharge Control Program
- New Development/Redevelopment Control Program

The measurable goals for each BMP, an implementation schedule for program activities, and the responsible entity must be identified in the permit application. Annual reports will be required over the five-year permit period. The entire program must be implemented by the end of the first five-year permit period.

The Department of Public Works has been working with other County departments and local municipalities to develop our SWMP. Many existing County funded programs such as the erosion control, road and drainage maintenance, septic system maintenance, sanitation inspection, development review, and integrated pest management programs comply with some of the NDPES Phase II requirements. However, some of these programs need to be expanded upon and all need to be documented as part of our SWMP. Local and regional programs also exist which satisfy some aspects of the Phase 11 requirements.

Additional funding will be required in order to prepare and implement our Phase II SWMP. Possible funding sources are drainage zone fees or establishing a storm water utility fee. Shared resources, such as advertising campaigns and volunteer labor from local environmental and concerned citizens groups, can also provide financial relief.

In January 2002, the Department of Public Works submitted a concept proposal for a Proposition 13 grant. The grant application requested funding for a series of projects that would qualify for the majority of the County's SWMP. If our concept proposal is approved, the Department of Public Works will ask your Board to allow us to submit a complete Proposition 13 grant application by June 2002. The Department of Public Works will continue to pursue additional grant opportunities including the 319(h) Nonpoint Source Implementation Grant.

In February 2002, Public Works staff met with representatives from the cities of Capitola, Santa Cruz, Scotts Valley, and Watsonville to discuss whether to submit our Phase II permit applications separately or as co-permittees under one regional permit. There are many advantages to applying as co-permittees. The advantages include shared costs for annual permit fees, public education and outreach, training and consultant fees. There would be no shared liability between co-permittees. We will report to your Board on the progress of this coordination with the cities at your June 21,2002 meeting.

Over the next year, the Department of Public Works, in cooperation with other County departments and local agencies and watershed groups, will develop our storm water management plan and NPDES Phase II application. As part of this process, public meetings will be held to solicit public and stakeholder input and participation. We will report back to your Board to keep you apprised of our progress.

It is therefore recommended that the Board of Directors accept and file this report, and direct Public Works to report back with updates and progress of work on the Phase II permit process at the June 21,2002, meeting.
