Approve Transfer of Funds for Fixed Asset Purchase in the Probation Department's South County Violence Suppression (Domestic Violence) Unit, funded by a Grant from the State Office of Criminal Justice Planning

Dear Members of the Board:

The Probation Department participates in a three-year Violence Against Women - Probation Specialized Unit program funded by Federal funds through the Office of Criminal Justice Planning (*OCJP*). This program created a specialized probation unit for South County, consisting of a Deputy Probation Officer and a Probation Aide to handle offenders of violent crimes against women, including sexual assault, domestic violence and stalking. This grant-funded program was scheduled to end on March 31, 2003, but was recently extended to September 30, 2002 by OCJP.

The Office of Criminal Justice Planning has approved a budget modification allowing the program to utilize savings incurred in the current year of operation to purchase needed capital equipment including three lap-top personal computer systems and a digital projector. This equipment will be used by Probation staff in the field to take notes, access the Probation case management system, and to make program-related presentations at public meetings.

It is now necessary to transfer and appropriate these funds in the Probation Grants Index, as detailed in the attached AUD-74 form. There is no increase in cost to the County associated with this action.

IT IS THEREFORE RECOMMENDED that your Board:

- 1. Approve the attached AUD-74 Transfer Request, authorizing the transfer of \$13,500 in the Probation Grants Index to Fixed Assets; and
- 2. Approve the fixed asset purchase of three (3) laptop computer systems and one digital projector as detailed in the attached AUD-74.
