REPORT BACK ON PROPOSED ORDINANCE AMENDMENTS REGARDING NONHABITABLE ACCESSORY STRUCTURES

Members of the Board:

On December 4,2001, your Board adopted Ord. 4646 which extends interim zoning regulations for nonhabitable accessory structures. Your Board directed staff to prepare a permanent ordinance and to return with **a** report on the applicability of the proposed ordinance in the rural area on lots over a quarter of an acre and the issue of the size of nonhabitable accessory structures (see Attachment A – Minute Order).

Staff has drafted a permanent ordinance which has completed environmental review. The Planning Commission considered the ordinance at a public hearing on February 27,2002, and continued their consideration for additional information. No change to the size limitation of nonhabitable accessory structures is proposed at this time; however, the Planning Commission had a lengthy discussion of the appropriate applicability of the proposed ordinance regarding lot size and other criteria and has directed staff to review the regulations of other jurisdictions. Staff will bring this information to the Planning Commission in late April. Once the Planning Commission has taken action, the matter will be set for public hearing before your Board.

RECOMMENDATION

It is, therefore, RECOMMENDED that your Board accept and file this report.


