SUBJECT: PARKING RESTRICTION ON STATE HIGHWAY ONE AT THE DAVENPORT VOLUNTEER FIRE DEPARTMENT

Members of the Board:

The Davenport Volunteer Fire Department has requested a "No Parking Any Time" zone on State Highway One at the Davenport Fire Station driveway. This no parking zone is needed to eliminate a sight distance problem for emergency vehicles turning out of the fire department driveway. Our department concurs that a no parking zone is needed on the north side of State Highway One for a distance of 100 feet west and 70 feet east of the driveway.

The County of Santa Cruz can request the creation of this no parking zone by adopting the attached resolution that requests the California Department of Transportation (CALTRANS) to prohibit parking on this portion of Highway One.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Adopt the attached resolution requesting CALTRANS to prohibit parking on State Highway One at the Davenport Fire Station driveway.
- Direct the Clerk of the Board to forward a certified copy of the resolution to CALTRANS District 5 Traffic Department, 50 Higuera Street, San Luis Obispo, CA 93401-5415

3. Direct Public Works to post the "NO PARKING ANYTIME" signs upon approval by CALTRANS.

On the motion of Supervisor duly seconded by Supervisor the following resolution is adopted:

RESOLUTION REQUESTING THE STATE OF CALIFORNIA
DEPARTMENT OF TRANSPORTATION (CALTRANS)
TO EXERCISE ITS AUTHORITY TO PROHIBIT PARKING
ON STATE HIGHWAY ONE AT THE DAVENPORT VOLUNTEER FIRE DEPARTMENT

WHEREAS, CALTRANS owns and is exclusively responsible for the control and maintenance of State Highway One and the property within the CALTRANS right-of-way; and

WHEREAS, the Board of Supervisors finds that the parking of vehicles on CALTRANS' owned and maintained property does cause a sight distance problem for emergency vehicles turning out of the Davenport Fire Station; and

WHEREAS, Vehicle Code Section 22506 permits the County to request that CALTRANS prohibit parking of vehicles on a State Highway; and

WHEREAS, such a County Board of Supervisors resolution must be submitted to and approved by CALTRANS in writing;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the Santa Cruz County Board of Supervisors request CALTRANS to exercise its authority to prohibit parking on the north side of State Highway One for a distance of 100 feet west and 70 feet east of the Davenport Fire Station driveway.

BE IT FURTHER RESOLVED that this resolution be forwarded to CALTRANS for consideration, review and approval.

BE IT FURTHER RESOLVED that upon approval by CALTRANS, the County Public Works Department is authorized to post the "NO PARKING ANY TIME" signs on State Highway One.
