On May 27, 1997, the parcel map for MLD 91-0757 was recorded. The developer of the project completed construction of the required improvements. The Public Works Department inspected the constructed improvements and found that they are complete and acceptable.



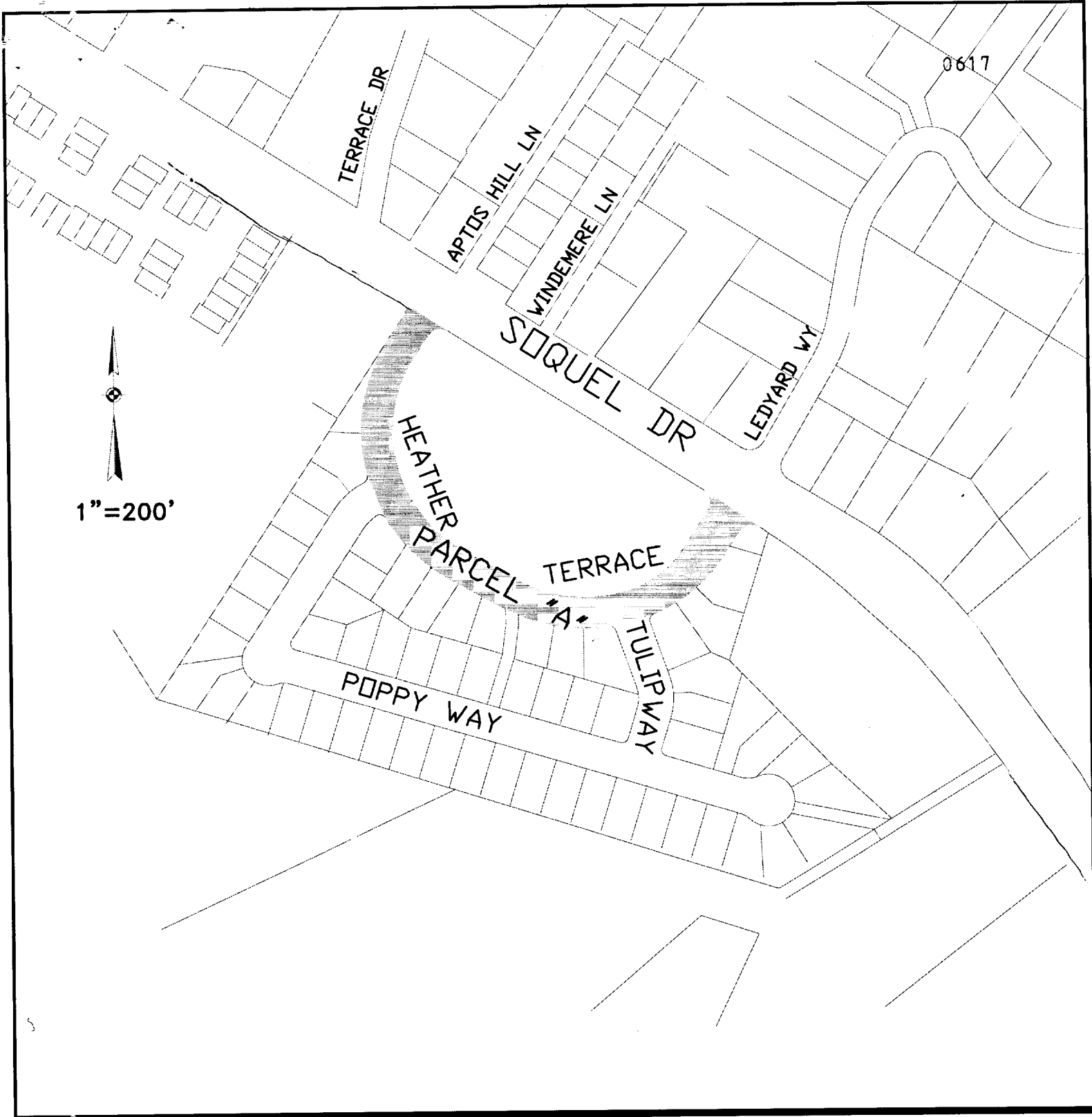
