**SUBJECT: SEASCAPE BOULEVARD AND PINEHURST DRIVE IMPROVEMENT PROJECT**

Members of the Board:

The plans, specifications and engineer's estimate for the Seascape Boulevard and Pinehurst Drive Improvement Project are complete and presented here for your consideration and approval. This project is designed to improve pedestrian access and safety, and includes road reconstruction work.

The Seascape Boulevard improvements include the reconstruction of 165 meters of roadway from Via Pacifica to San Andreas Road. A new sidewalk (185 meters) will be constructed along the south side of the road with a new bus pullout near the Via Pacifica intersection. The Pinehurst Drive improvements consist of new sidewalk and school crosswalks on Pinehurst Drive at the pedestrian access point to Rio Del Mar Park.

The engineer's estimate for the subject project is \$292,050 not including contingencies and administration. Sufficient funding for this project is available in the approved 2001/2002 road fund using Aptos Transportation Improvement Area fees.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications and engineer's estimate, and authorize calling for bids.



NOTICE TO CONTRACTORS**

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than **10:30 a.m., May 21, 2002**, and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on County roads in accordance with the specifications therefor, to which special reference is made, as follows:

**SEASCAPE BOULEVARD AND PINEHURST DRIVE IMPROVEMENT PROJECT**

This project involves improvements on a portion of Seascap Boulevard and Pinehurst Drive. The Seascap Boulevard improvements consist of irrigation and landscaping, drainage system, the reconstruction of 165 meters of road from Via Pacifica to San Andreas Road including the construction of 185 meters of sidewalk along the south side of the road with a new bus pull out near Via Pacifica. The Pinehurst Drive improvements consist of new sidewalk and bollards on Pinehurst Drive at the pedestrian access point to Rio Del Mar Park.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required.

The successful bidder shall furnish a payment bond and a performance bond.


The Contractor shall possess a Class "A" license at the time that this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.

Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the District has been determined by the Director of the Department of Industrial Relations, and such prevailing rate of wages is listed in the State of California, Business and Transportation Agency, Department of Transportation's publication entitled General Prevailing Wage Rates, current edition, on file in the office of the Director of Public Works.
