SUBJECT: ALICE STREET AND CORCORAN AVENUE IMPROVEMENTS

Members of the Board:

Included in the 2001/02 Redevelopment Agency, Public Works, and Santa Cruz County Sanitation District budgets are funds for the construction of the subject roadway, roadside, landscaping, drainage, and sanitary sewer improvements.

The plans, specifications, and estimate have been completed for the subject project, and are presented here for your consideration and approval. The total engineer's estimate for this project is \$1,332,150.00, not including contingencies and administration. Sufficient funds are available for this project.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids.
- 2. Set bid opening for 10:45 a.m. on April 30,2002.
- 3. Adopt the attached resolution allowing the bid opening for the subject project to take place in the office of the Director of Public Works at 10:45 a.m. on April 30,2002, with acceptance and award by the Board on May 7,2002.
