The Felton Business Association is sponsoring the 34<sup>th</sup> annual "Race Through The Redwoods" in Felton on Sunday, August 18, 2002. The 10K race, which starts in front of New Leaf Market, proceeds south on Highway 9 to Henry Cowell State Park, into the park, and back out to New Leaf Market, is a benefit for several San Lorenzo Valley nonprofit community organizations. The starting time for the kid's mile will be 8:10 a.m. The 10K will start at 8:30 a.m.


