APPROVE PURCHASE OF FIXED ASSETS

Dear Chairperson Beautz and Members of the Board:

The Department of Child Support Services was allocated \$12,000 in Fiscal Year 2001/02 for certain recurring EDP M&O expenses. These funds were requested for anticipated programming charges and printer maintenance and are not likely to be claimed this year. State Department of Child Support Services has recommended this allocation be used to fund a non-recurring purchase of replacement printers in the current fiscal year, given the uncertainty of EDP project funding in the coming year.

State Department of Child Support Services has also recommended accelerating the planned replacement of laptop computers in this fiscal year while administrative funding is available.

IT IS THEREFORE REQUESTED THAT YOUR BOARD:

- 1. Approve the purchase of 5 HP LaserJet Printers at a cost not to exceed \$12,000.
- 2. Approve the purchase of 4 replacement laptops, vendor and model to be determined at a cost not to exceed \$12,500.
- 3. Approve Request for Transfer or Revision of Budget Appropriations and/or funds.(AUD-74).
