APPROVAL OF CONTRACT AMENDMENT TO LEVERAGE PROP 10 FUNDS FOR ANSWERS BENEFITING CHILDREN PROGRAM

Dear Members of the Board:

As you know, the Human Resources Agency (HRA) administers a contract with Santa Cruz Community Counseling Center (SCCCC) to provide coordination and direct services for the Answers Benefiting Children (ABC) program. As part of the collaborative design of ABC, SCCCC subcontracts with several community-based organizations to deliver the range of ABC family support services at the La Manzana Community Resources center in Watsonville. As you will recall, ABC services include intensive home visiting to families with young children, center-based activities and child abuse treatment services. ABC is funded by a 3-year grant from the Office of Child Abuse Prevention, as well as a mix of state, federal and local cash and in-kind resources, including a grant from the Children and Families Commission.

In the upcoming fiscal year (FY 2002/03), the OCAP portion of the ABC fimding will sunset. For this reason, HRA and the other ABC partner agencies have developed strategies to leverage fimding in the current fiscal year in order to support and sustain ABC services next year. We are proposing to redirect a total of \$70,780 in federal TANF Incentive fimds already budgeted in HRA's N 01/02 ABC budget to the Santa Cruz Community Counseling Center contract. These fimds will be used to support the home visiting and center-based services component of ABC and will allow SCCCC to leverage Children and Families Commission funds for the 2002/03 fiscal year. This letter requests your Board's approval of the attached amendment to the current contract with Santa Cruz Community Counseling Center to add \$70,780 in TANF Incentive fimds. This amendment will result in no additional cost to the County.

AMENDMENT #4 TO AGREEMENT ANSWERS BENEFITING CHILDREN PROJECT

0032

The County of Santa Cruz, by and through the Human Resources Agency, hereinafter referred to as "COUNTY" and SANTA CRUZ COMMUNITY COUNSELING CENTER, hereinafter referred to as "CONTRACTOR", hereby amend contract number 11916 which provides Answers Benefiting Children (ABC) services from July 1, 1999 through June 30, 2002. The purpose of this amendment is to modify the FY 2001/2002 contract budget to increase the budget in the amount of \$70,780 in TANF Incentive funds. These additional funds will be used to accomplish goal #4 of the TANF regulations, i.e., to encourage the formation and maintenance of two-parent families. All other provisions of said contract shall remain the same.

(A) Paragraph 3.A. is amended to read:

3. BASTS OF PAYMENT

- A. In consideration of services rendered, COUNTY shall pay CONTRACTOR on the basis of appropriate claims submitted to the Human Resources Agency in accordance with Exhibit "A" (Budget), incorporated herein by reference, to **be** submitted by CONTRACTOR to COUNTY prior to the release of any payments under this Agreement.
- (B) Exhibit "A" (Budget) is amended as attached.
