Members of the Board:

Included in the 2001/02 Redevelopment Agency, Public Works, and the Santa Cruz County Sanitation District budgets are funds for the construction of the subject roadway, roadside, landscaping, drainage, and sanitary sewer improvements.


The plans, specifications, and estimate have been completed for the subject project, and are presented here for your consideration and approval. The total engineer's estimate for this project is \$2,429,352.00, not including contingencies and administration. Sufficient funds are available for this project.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids.
2. Set bid opening for 10:45 a.m. on May 7, 2002.

3. Direct the Clerk of the Board to advertise a "Notice to Contractors" for a 10-day period beginning April 21, 2002, in accordance with the provisions of Public Contract Code Section 20392.


