This contract provides for the demolition of the structure at 1133 Amesti Road under the Landslide Hazard Mitigation Program. Because of a number of delays in the escrow process for acquisition of this property, along with adverse site conditions caused by early fall rains, the demolition of this structure could not be completed by the end of the original contract term. In order to approve payment for the demolition, the term of the contract must be extended from June 30, 2001 to January 30, 2002.

It is, therefore, RECOMMENDED that your Board approve the attached contract amendment and authorize the Emergency Services Administrator to execute the amendment on behalf of the County.
