NOTICE OF COMPLETION: 265 Water Street Remodel Project

Members of the Board:

The 265 Water Street Remodel project was completed on April 4, 2002 by Bustichi Construction. This project consisted of the repair and remodel of the existing property for Health Services Agency office staff occupancy; including roofing, electrical, plaster-drywall, bathroom, doors, ramp/stairs painting data/telephone and heating, ventilation and air conditioning. The original bid amount was \$88,414. There has been one approved change order which increased the final cost of the project by \$8,500. The approved items on the change order included the replacement of the existing heating system with a new furnace and installation of new gas lines, electrical lines, new heat outlets, piping and thermostat; the replacement of a countertop and sink; raising of a doorway height and the removal of brush around the structure to facilitate painting. The final construction cost is \$96,914.

It is therefore RECOMMENDED that your Board take the following actions:.

1. Accept the project as completed;

2. Approve the final cost of \$96,914; and

3. Authorize the Clerk of the Board to file the executed Notice of Completion with the Office of County Recorder, a copy of which is attached.
