Resolution Approving the Santa Cruz County ComprehensiveMulti-Agency Juvenile Justice Plan Modification for FY 2002-03

Dear Board Members:

On April 17, 2001, your Board approved the Probation Department's submission of the County's Multi-Agency Juvenile Justice Plan and Funding Application to the State Board of Corrections (BOC) for the Schiff-CardenasCrime Prevention Act of 2000 program. The application was approved by the BOC on April 23,2001, and funds in the amount of \$935,737 were included in the supplemental budget for FY 2001-02. The BOC recently provided information regarding the second allocation of funds for programs included in the County's approved spending plan. Recent changes as a result of SB 736 require the local Juvenile Justice Coordinating Council to review and modify annually its comprehensive plan, and for the County Board of Supervisors and State Board of Corrections to approve the modified plan. Changes also include the removal of the sunset clause for the program, which is now titled the Juvenile Justice Crime Prevention Act (JJCPA) program. Second year funding for Santa **Cruz** County is \$867,945, and in addition there are estimated interest earnings in the amount of \$36,000 and leveraged Title IV-E funds in the amount of \$36,000 that are allocated to this program, for a total budget of \$939,945 for FY 2002-03.

As a result of these new requirements, your Board re-authorized the Juvenile Justice Coordinating Council (JJCC) on March **5**, 2002. On April 8, 2002, Probation staff as well as program partners from the County Health Services Agency, County Office of Education, and community-based organizations provided information to the JJCC regarding the current year program and presented a proposed budget for FY 2002-03 with changes reflecting only the reduction in allocation of State funds. There are no substantive program changes required for the plan modification. At this meeting the JJCC unanimously passed a motion to accept and approve the Santa Cruz County Comprehensive Multi-Agency Juvenile Justice Plan Modification for FY 2002-03. Attached to this letter is a brief description of the two programs included in the plan.

Also attached to this letter is a copy of the Comprehensive Multi-Agency Juvenile Justice Plan Modification - Application for Approval to be submitted to the Board of Corrections, which includes a summary budget that identifies program areas and budget amounts for the current year as well **as** the modifications necessary for FY 2002-03. It is now necessary to obtain final approval from your Board to submit the program modification application to the Board of Corrections no later than May 1,2002. There is no County cost associated with this program.

<u>Santa Cruz County Comprehensive Multi-Agency Juvenile Justice Plan - Program</u> <u>Components</u>

During the fiscal year 2001-02, the Probation Department received Crime Prevention Act of 2000 (**AB** 1913) funds to develop and provide services to probation-involved youth and families. These funds were used to create the Community Accountability Program (CAP) and the Strength-based Treatment Assessment and Recovery Program (STAR).

CAP provides geographically based probation services for first time and early offenders who qualify for diversion and informal interventions. It also provides intensive supervision services for youth on formal probation who reside in the program areas. It takes a community focus in close partnership with law enforcement agencies, family resource centers, and community organizations providing services in three county locations: the Santa Cruz Mountains, Live Oak Community, and the City of Watsonville. Services are built upon the Probation Department's Balanced and Restorative Justice practices. Community involvement in pre-adjudicated cases include participation in Victim Offender Dialogue program and Neighborhood Accountability Boards in each area. For youth whose offenses have harmed the school community, referrals are made to teen peer court. Offender competency building programs include research-based best practices, such as cognitivebehavioral programs and family focused interventions for both pre-adjudicated and post-adjudicated youth. Victim reparation and restitution payments are a program focus. Intensive supervision with services from the community centers are applied to small caseloads staffed by four probation officers in each of the three community locations. Community work service projects, job mentorship and job placement services are provided on an individualized basis.

The STAR program is a collaboration between Children's Mental Health, Drug and Alcohol Services and Probation. STAR is a strength-based, short-term residential treatment program that provides residential treatment for up to 12 youth. The programs serve youth who can benefit from assessment and transitional planning in a residential setting which focuses on substance abuse problems. The short-term intervention assists in maintaining an emphasis on the factors and conditions that brought the youth to the treatment facility and the factors and conditions that must be addressed before the transition to the least restrictive level of aftercare that will benefit the youth and sufficiently address public safety issues. The maximum stay is 90 days.

Assures the County of Santa Cruz will adhere to the requirements of the Juvenile Justice Crime Prevention Act (Chapters 353 and 475 of the Government Code) regarding the submission of the Comprehensive Multi-Agency Juvenile Justice Plan Modification application, investment of allocated monies, including any interest earnings, expenditure of said funds, and the submission of required reports to the Board of Corrections.

Decrease in estimated interest earnings, from \$66,491 to \$36,000, a decrease of \$30,491.

Increase in program-related revenue generated by Probation staff performing reimbursable activities under Federal Title IV-E funds; estimated at \$36,000 for FY 2002-03.
