SUBJECT: HUTCHINSON ROAD SLIPOUT REPAIR PROJECT,  
HUTCHINSON ROAD COUNTY SERVICE AREA NO. 13 (DISTRICT 5)

#### Members of the Board:

The plans, specifications and engineer's estimate for the Hutchinson Road Slipout Repair Project are complete and presented here for your consideration and approval. The project provides for repairing the slipout damage adjacent to Hutchinson Road through the construction of a soil nail wall, reconstruction of the pavement section and revegetation of all graded slopes.

The engineer's estimate for this project is \$251,000, not including contingencies and administration. Sufficient funds are available in the County Service Area No. 13 budget to cover this expenditure.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids for the Hutchinson Road Slipout Repair Project.
2. Set bid opening for 10:45 a.m. on May 21, 2002.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning April 28,2002, in accordance with provisions of the Public Contract Code Section 20392.

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than **10:30 a.m., May 21, 2002** and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for a road repair project on Hutchinson Road in accordance with the specifications therefor, to which special reference is made, as follows:

**HUTCHINSON ROAD  
SLIPOUT REPAIR PROJECT**

The work to be done consists, in general, of the repairing the slipout damage adjacent to Hutchinson Road by building a soil nail wall on the failing slope and a return wall at the termination of the existing bridge.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class A license at the time this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award. Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the District has been determined by the Director of the Department of Industrial Relations, and such prevailing rate of wages is listed in the State of California, Business and Transportation Agency, Department of Transportation publication entitled General Prevailing Wage Rates, current edition, on file in the office of the Director of Public Works.
