SUBJECT: SALSIPUEDES CREEK LEVEE REPAIR PROJECT

Members of the Board:

The plans and specifications for the subject project are complete and presented here for your consideration and approval. The proposed project consists of installing approximately 1000 linear feet of sheet piles into the existing western Salsipuedes Creek levee downstream of the Highway 129 crossing to eliminate a series of seeps and reestablish the levee integrity.

The engineer's estimate is \$310,000, not including contingencies and administration. On August 3, 1999, your Board executed and authorized by Resolution No. 349-99, a contract with the Department of Housing and Community Development for a State Disaster Recovery Initiative Grant Agreement. This grant provides \$555,440 in funding for this project, of which, \$397,500 is available for construction related expenses. Local match funding for the project has been included in the 2001/2002 Pajaro Storm Drain Maintenance District budget.

It is therefore recommended that the Board of Directors take the following action:

1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids.
2. Set the bid opening for 10:45 a.m. on May 21, 2002.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning April 28, 2002, in accordance with the provisions of the Public Contract Code, Section 20392.



NOTICE TO CONTRACTORS

Sealed proposals shall be delivered to the District Engineer of the Pajaro Storm Drain Maintenance District, Room 410, Governmental Center, no later than 10:30 a.m., May 21 2002, and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on the referenced Public Works project in accordance with the specifications therefore, to which special reference is made, as follows:

**SALSIPUEDES CREEK LEVEE
REPAIR PROJECT**

The work to be done consists in general of installing sheet piles into an existing earthen levee along the Salsipuedes Creek as shown on the plans and described in the special provisions.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the District Engineer, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class A license at the time this contract is awarded.

The District hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.

Pursuant to federal labor standards requirements and to the Labor Code of the State of California, or local law thereto applicable, the District Engineer has ascertained the general prevailing rate of per diem wages and rates for holidays and overtime work in the locality in which this work is to be performed, for each craft, classification or type of laborer, worker or mechanic needed to execute this Agreement. The prevailing wages so determined are as set forth in Attachment A to these specifications. When there is a difference between the state and federal wage rate, Contractor must pay the higher rate. Contractor will submit certified payrolls to the District Engineer within 7 days of the end of each payroll period.
