SUBJECT: PUBLIC HEARING TO CONSIDER ORDINANCE TO RESTRICT COMMERCIAL VEHICLE PARKING ON MC GLENN DRIVE

Members of the Board:

On April 23,2002, your Board adopted a resolution to set a public hearing for May 7,2002, to consider an ordinance to restrict commercial vehicle parking (over 10,000 lbs.) on McGlenn Drive. Notice of this public hearing has been advertised in the Santa Cruz Sentinel, posted on the affected portion of McGlenn Drive, and mailed to each resident at least ten days before the public hearing. The registered voters of McGlenn Drive, from the intersection of Aster Lane to the end, have submitted a petition to the Department of Public Works with a 59 percent approval rate along with the required administrative processing fee to request the parking restriction of commercial vehicles on that segment of road (see attached map). The procedure outlined in County Code Section 9.70.600 requires that the Board of Supervisors hold a public hearing to consider the issue. If the commercial vehicle parking restriction is approved by your Board, the McGlenn Drive residents will be required to pay for the installation of the signs per the Santa Cruz County Code.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Open the public hearing and hear objections or protests, if any, to the proposed commercial vehicle parking restriction on McGlenn Drive.
- **2.** Close the public hearing.
- 3. Consider adoption of the attached ordinance in concept to restrict commercial vehicle parking on McGlenn Drive.

- 4. Direct the Clerk of the Board to place the ordinance on the next available agenda for final adoption.
- 5. Direct the Department of Public Works to post signs indicating the commercial vehicle parking restriction on McGlenn Drive **3**1 days after final adoption of the ordinance and after the residents have paid for installation of the signs.

ORDINANCE AMENDING CHAPTER 9 OF THE COUNTY CODE

RELATING TO COMMERCIAL VEHICLE PARKING

SECTION I

CHAPTER 9.70 STREETS AND ROADS is hereby amended by adding Section 9.70.601 to read:

9.70.601 Commercial Vehicle Parking Restrictions. The following streets or portions thereof, as indicated below are designated to be unlawful to park a commercial vehicle having a gross vehicle weight of ten thousand pounds or more, pursuant to Section 9.70.600 of this code:

1. McGlenn Drive, from Aster Lane to the end.

SECTION II

This ordinance shall take effect on the 31st day after final passage.
