APPOINTMENT OF INTERIM PUBLIC GUARDIAN

Dear Members of the Board:

The Human Resources Agency (HRA) is in the process of developing a recruitment plan for the upcoming vacant position of Chief Public Guardian. In order to assure legal authority for various public guardian actions under the Welfare and Institutions Code, it is necessary that your Board make an appointment to the Office of Public Guardian on an interim basis until a Chief Public Guardian is hired and appointed. HRA is recommending that the Director of the Adult and Long Term Care Division of HRA, Don Allegri, be designated for this appointment. As provided by Section 2.12.020 of the County Code, a resolution of your Board is required.

IT IS THEREFORE RECOMMENDED that your Board adopt the attached resolution appointing Don Allegri to the Office of Public Guardian of Santa Cruz County.

On the motion of Supervisor duly seconded by Supervisor the following resolution is adopted.

RESOLUTION APPOINTING DON ALLEGRI AS PUBLIC GUARDIAN OF SANTA CRUZ COUNTY

WHEREAS, Chapter 2.12 of the Santa Cruz County Code authorizes the office of public guardian to provide conservatorship services required by the applicable provisions of the Welfare and Institutions Code and the Probate Code; and

WHEREAS, Section 2.12.020 of the Santa Cruz County Code provides that the public guardian shall be appointed by resolution of the Board of Supervisors and shall exercise the authority of that office for two year terms or until the termination of the office upon order of the Board of Supervisors; and

WHEREAS, the Human Resources Agency is the umbrella agency responsible for administering the Public Guardian Office; and

WHEREAS, there will be a vacancy in the office of the Public Guardian after June 7, 2002;

NOW, THEREFORE BE IT RESOLVED that Don Allegri is hereby appointed to the office of public guardian of Santa Cruz County for a term beginning June 8, 2002 and ending upon the termination of the office by order of the Board of Supervisors.
