SUBJECT: SOQUEL DRIVE SIDEWALK MPROVEMENT PROJECT

Members of the Board:

The plans, specifications and engineer's estimate for the Soquel Drive Sidewalk Improvement Project are complete and presented here for your consideration and approval. This project is designed to improve pedestrian access and safety.

The sidewalk improvements will provide a continuous pedestrian network from Soquel Village to Aptos Village. This particular project will construct 2,350 linear feet of sidewalk on the south side of Soquel Drive from Vienna Drive to Heather Terrace. This work will also provide a critical sidewalk connection on Soquel Drive for children attending the Mar Vista Elementary School.

The engineer's estimate for the subject project is \$311,051, not including contingencies and administration. Sufficient funding is contingent upon approval of \$405,000 for this project in the fiscal year 2002/03 budget from the Aptos Transportation and Roadside Improvement Funds.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Approve the plans, specifications, and engineer's estimate, and authorize calling for bids.
- 2. Set bid opening for 10:45 a.m. on June 11,2002.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning May 26,2002, in accordance with provisions of the Public Contract Code Section 20392.

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than **10:30 a.m., June 11,2002,** and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on County road in accordance with the specifications therefore, to which special reference is made, as follows:

SOQUEL DRIVE CURB, GUTTER AND SIDEWALK FROM VIENNA DRIVE TO HEATHER TERRACE

This project consists of road and pedestrian improvements on the south side of Soquel Drive from Vienna Drive to Heather Terrace. It will include the construction of curb, gutter, sidewalks, retaining walls, and landscaping.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required.

The successful bidder shall furnish a payment bond and a performance bond.

The Contractor shall possess a Class A license at the time that this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.
