SUBJECT: SALSIPUEDES CREEK LEVEE REPAIR PROJECT AWARD OF CONTRACT

Members of the Board:

On May 21,2002, your Board received three bids for the Salsipuedes Creek Levee Repair Project. All bids were found to be in order. The engineer's estimate was \$310,000. The low bidder was Granite Construction Company of Watsonville, California in the amount of \$352,352. Sufficient funds, including contingencies and administration, are available to cover this expenditure through a contract with the Department of Housing and Community Development for a State Disaster Recovery Initiative Grant Agreement (see attached Resolution No. 349-099). Local match funding for the project has been included in the 2001/2002 Pajaro Storm Drain Maintenance District budget.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Accept the low bid of Granite Construction of Watsonville, California in the amount of \$352,352 and authorize the award of contract.
- 2. Authorize the Director of Public Works to sign said contract on behalf of the County.

NOW, THEREFORE, the Board of Supervisors of the County of Santa Cruz resolves as follows:

- 1. The Board of Supervisors has reviewed and hereby approves an application for: The Pajaro/Salsipuedes levee system repair and flood control project.
- 2. If the grant application is approved, the County will provide a 25% program match as follows: \$132,500 from the 1999/00 Pajaro Storm Drain Maintenance District Budget.
- 3. The Director of Public Works is hereby authorized and directed to act on the County's behalf in all matters pertaining to this application.
- **4** If the application is approved, the Director of Public Works is authorized to enter into and sign the grant agreement and any amendments thereto with the State of California for the purposes of this grant.
