APPROVE REGULATION CHANGES TO THE GENERAL ASSISTANCE PROGRAM

Dear Members of the Board:

As you know, General Assistance (GA) is a state mandated, 100% County-funded program that provides cash assistance to eligible disabled or unemployed single adult county residents who are ineligible for other aid programs. Each year the GA program regulations are reviewed for compliance with state law under the Welfare and Institutions Code 17000. Regulations are revised based on regulatory or administrative changes. The purpose of this letter is to have your Board approve recommended changes to the General Assistance program regulations effective July 1,2002.

This year, there are only minor GA regulations changes proposed. Minor wording changes are included such **as** replacing "AFDC" with "CalWORKs" and "Alien" with "Non-citizen". In addition, there is an increase in time allowed for the GA client to report changes in income or other circumstances that may affect eligibility. This increase, from 5 to 10 days, is consistent with the Food Stamp program. The majority of GA recipients are also Food Stamp recipients. As legally mandated and per previous Board resolution, the proposed GA budget for FY 02/03 reflects the most recent CalWORKs cost of living increase of 5.31%. These changes have been reviewed and approved by the Human Services Commission and California Rural Legal Assistance. A *summary* of the changes is attached.

IT IS THEREFORE RECOMMENDED that your Board approve recommended changes to the General Assistance program regulations effective July 1,2002.
