APPROVAL OF RECEPTION SERVICE CONTRACTS WITH EMPLOYMENT DEVELOPMENT DEPARTMENT FOR WATSONVILLE AND CAPITOLA CAREER CENTERS

Dear Members of the Board:

On October 3, 2000, your Board approved contracts with the Employment Development Department (EDD), a partner in Workforce Santa Cruz County, to provide reception services in two career centers from July 1, 2000 through June 30, 2001. EDD continued to provide reception services effective July 1,2001 pending renewal of the contracts for FY 2001-02. Despite the approval of the FY 01-02 Cost Allocation Plan for the Watsonville and Capitola Career Centers by the Workforce Investment Board in August 2001, further negotiation between EDD and HRA around specific lease and operator costs was required. Unfortunately, the local EDD office does not have the authority to sign and approve the cost allocation plan; therefore, it was necessary to negotiate the increase and operator costs with a variety of bureaus within the State EDD office. The negotiations took over ten months to complete due to the review and approval process at the state level, and the protracted time to arrive at consensus. The Human .Resources Agency has now finalized two contracts to fund reception services for the period of July 1, 2001 through June 30, 2002 in the amounts of **\$5**1,327 and \$77,329 for the Watsonville and Capitola career centers respectively. The purpose of this letter is to recommend approval of these contracts with EDD, and to authorize the Human Resources Agency Administrator to sign the contracts.

The Watsonville reception cost of **\$5**1,327 is funded by the partners and programs in the career center outlined in the Watsonville Career Center FY 01/02 Cost Allocation Plan and approved by the Workforce Investment Board. The Capitola reception cost of \$77,329 is funded through the Workforce Investment Act, Rapid Response funds. There are no County costs associated with these contracts. The contracts will begin July 1,2001 and continue through June 30,2002. The contracts, which are based on a State boilerplate, are on file with the Clerk of the Board, and have been approved as to form and insurance by County Counsel and Risk Management.

IT **IS** THEREFORE RECOMMENDED that your Board:

- 1. Approve the contracts with the Employment Development Department for reception services in the amount of \$51,327 for the Watsonville Career Center, and in the amount of \$77,329 for Capitola Career Center: and
- 2. Authorize the HRA Administrator to sign the contracts on behalf of the County.
