APPROVE REALIGNMENT OF FUNDS AND PURCHASE OF FIXED ASSETS

Dear Members of the Board:

Revenues and expenditures for Fiscal Year 1998-99 have been audited and excess funds identified that may be used in support of program activities in the current fiscal year, or returned to the State. Therefore, the Department of Child Support Services requests authorization to purchase two additional vehicles to support program activities in its South County office and to promote the efficient completion of State mandated training and outreach functions. The Department will consider "green" vehicles and will communicate its vehicle needs to General Services upon approval of this request.

IT IS THEREFORE RECOMMENDED THAT YOUR BOARD:

- 1. Approve the purchase of two vehicles for child support program activities, and:
- 2. Authorize the transfer of \$60,000 as detailed in the attached AUD-74 Request for Transfer or Revision of Budget Appropriations and/or Funds: and
- 3. Adopt attached resolution accepting \$60,000 in unanticipated revenue within General Services Fleet Services and authorize Fleet Services to purchase two new vehicles for the Department of Child Support Services.
